## ***Political momentum***

1. Following the first High-Level Meeting of the Global Partnership for Effective Development Co-operation, **a key priority will be to sustain and further build the Partnership's political momentum**, and to ensure that the outcomes and initiatives emerging from the HLM can inform other relevant processes at the global, regional and country level. This guiding document has been prepared to help guide the work of Global Partnership over its next cycle leading up to the Second High Level Meeting, expected in 2016.
2. This document highlights **key entry points for member-driven engagement with other development fora at country, regional and global levels** and will be regularly updated as the work and agenda of Global Partnership move forward.

## ***Linking to global and regional discussions***

3. At the global level, the Partnership will need to ensure linkages with the discussions on the post-2015 development agenda anchored at the UN, culminating in the expected adoption of the new agenda in September 2015. Members can reflect on how to use the Partnership's activities over the coming period to position itself as **a useful tool to support implementation of the post-2015 development agenda**. Members are also encouraged to identify concrete ways to input the Partnership's substantive discussions into relevant processes at the General Assembly, High Level Political Forum, Development Cooperation Forum, Financing for Development conference, and elsewhere.
4. Steering Committee members will play a vital role in ensuring that **links with regional fora and processes help translate global discussions into action at the country level**, and feed evidence and priorities from the country to the global level. Members are encouraged to identify ways to feature relevant discussions at key regional meetings; and to consider how to use make use of dedicated regional-level activities, including workshops.
5. Steering Committee members will also provide a key link to important thematic and constituency-based fora, such as the G20, the World Economic Forum, and key gatherings of civil society, parliamentarians, foundations, local governments and other groups.
6. The **Committee is invited to identify member-led opportunities** to link with key fora, for example by **identifying champions** to convey inputs or key messages; **preparing formal inputs/submissions**; **organizing side events**; or communications products.

## ***Turning vision into action***

7. The first High-Level Meeting confirmed that the **focus of effective development co-operation should be on country-level implementation**. The voluntary initiatives launched in Mexico City provide an engine for driving implementation efforts. They complement the work carried out by the Building Blocks launched in Busan, some of which continue to be actively engaged.
8. Champions of voluntary initiatives and building blocks alike will need to **play a proactive role in following up on their commitments and leading by example**. A concrete step forward in this direction would be for these champions to inform Steering Committee members of their plans to drive

progress forward, identify key challenges, and share lessons learned from the activities carried out so far.

9. In sharpening the vision for the Global Partnership in the next biennium, members are encouraged to **provide additional contributions or ideas to implement Busan commitments**. This could take the form of an additional voluntary initiative, for example. The list of voluntary initiatives remains a living document that will be updated on an ongoing basis (link to website to be provided).
10. Another useful contribution by champions of voluntary initiatives and building blocks could be to identify the best opportunities to feed this information and substantive work into other major development fora so as to incentivise and benefit from global development dialogue.
11. Alongside specific initiatives, **individual action from all Global Partnership stakeholders will be needed to uphold the Busan commitments and further reform co-operation practices for better results**.

### ***Towards 2016***

12. In addition to the member-driven events described above, there will be opportunities for a limited number of core Global Partnership activities and events. The key event will be the next High Level Meeting, and members are invited to reflect on **how the timing and focus of the event could best complement discussions taking place in other fora**, particularly the post-2015 discussions at the UN.
13. Members may also wish to reflect on how to best make use of key intermediate events, including side events on the margins of major meetings; the annual workshop on Busan implementation in Seoul, Korea; and regional workshops.
14. The chart and list below provide an overview of key events and processes. Members are encouraged to provide additions to the list.

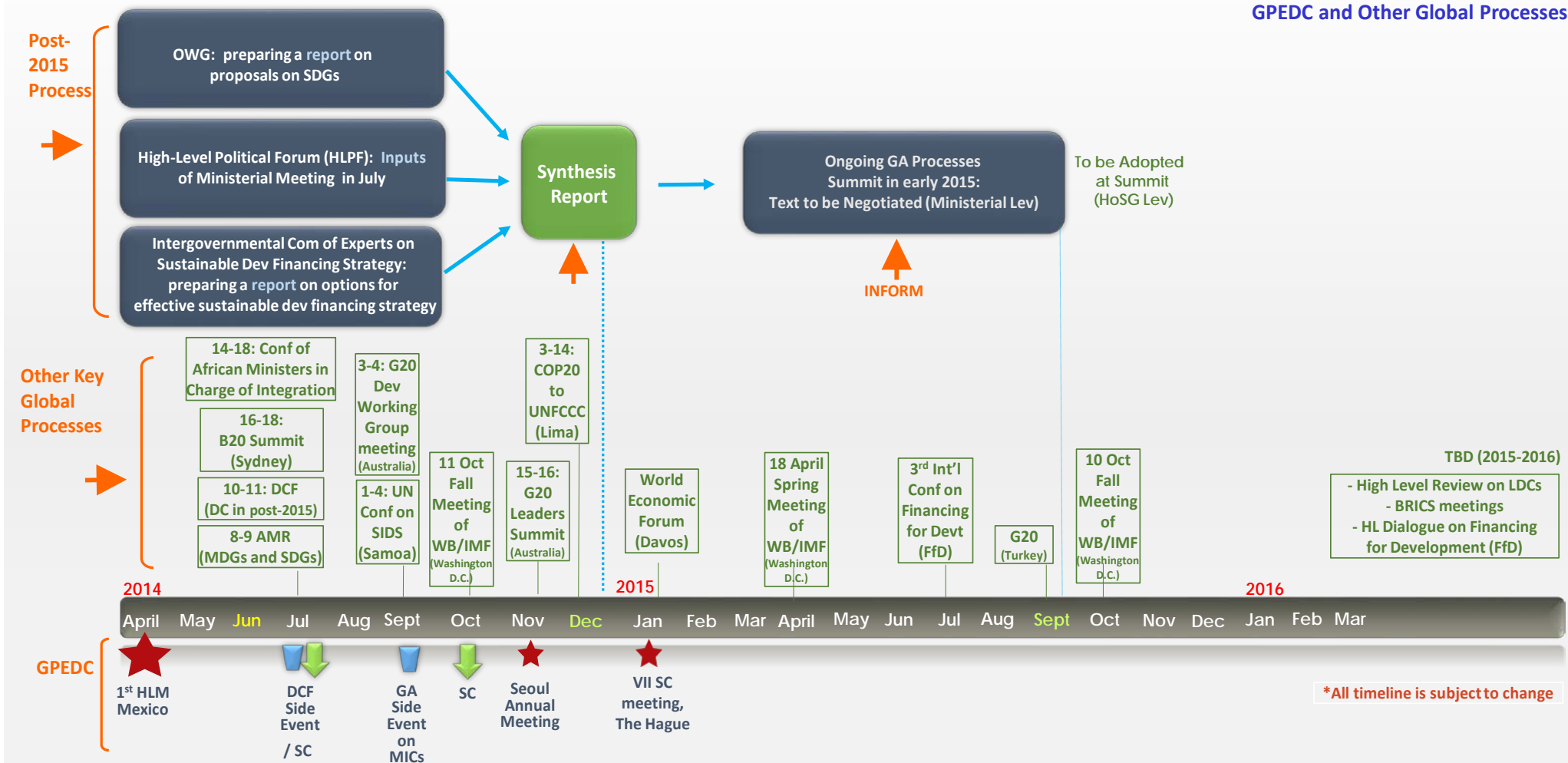
