#### Workshop Objectives

The workshop will provide an opportunity for representatives from pilot countries to share their experiences. Participants will present and discuss the activities undertaken, key results delivered, and challenges faced and successes achieved in the implementation process. The objective of the workshop is to spur further action to enhance effectiveness at country level through the direct exchange of experiences among the pilot countries, as well as the documentation of these experiences and lessons learned to shape the discussions at the Global Partnership's 2019 Senior Level Meeting (SLM) and to inform how the Global Partnership can support future country-level work. In this regard, the key outputs from the workshop will be a collection of good practices for the Global Compendium of Good Practices, messages for the SLM on key issues and priorities from country level and suggestions for further country-level support in the next Global Partnership work programme.
