#### **ABOUT THIS PUBLICATION**

- Explains the nature of this publication and why it differs from the previous institutional Monitoring Reports: there is no new GPEDC monitoring round, therefore evidence comes from the Action Dialogues and work at country level from the GPEDC Work Programme.
- It is a Summit Publication that showcases GPEDC’s progress towards advancing more effective development co-operation at the country level.

#### **INTRODUCTION**

- Highlights how key global trends and the evolving aid landscape presents new challenges and opportunities to progress more effective co-operation and partnerships that deliver country priorities and global progress towards agenda 2030, in line with SDG 17.
- Introduces how the GPEDC offers a unique multi-stakeholder platform to maintain the pulse of the global effective development co-operation agenda and ensures it informs effectiveness reforms at the country level and vice-versa.

#### **1. CRITICAL IMPORTANCE OF ADVANCING MORE EFFECTIVE DEVELOPMENT CO-OPERATION PARTNERSHIPS**

##### **1.1 Showcasing how the principles remain valid in a dynamic global context**

- Presents recent good practices across countries of how applying the different effectiveness principles has strengthened broadly-owned, country-led development processes towards producing long-lasting positive impact, where needs are greatest.
- Focuses on how the effectiveness principles play out in fragile contexts in support of the implementation of the “New Deal for engagement in fragile states” and implementing the “Humanitarian Development Peace Nexus”.
- Introduces the critical issues for more effective development co-operation for the provision of global public goods from the perspective of the effectiveness of climate-related development finance.

##### **1.2. Existing country-level effectiveness architecture enables making more rapid progress**

- Presents the evidence of country-level effectiveness mechanisms in constant evolution as a result of the increasing variety of different stakeholders shaping the development co-operation and partnership landscape.
- Argues for a sustained focus on strengthening existing national effectiveness “enablers” towards building stronger development co-operation partnerships.

## 2. SHOWCASING PROGRESS TO PROMOTE MORE EFFECTIVE DEVELOPMENT COOPERATION PARTNERSHIPS AT THE COUNTRY LEVEL

- Showcases significant progress towards mobilizing other sources of development finance, beyond ODA, through stronger development cooperation partnerships.

### 2.1 Using Integrated National Financing Frameworks to better apply the Effectiveness Principles across national development cooperation partnerships

- Illustrates the relevance of INFFs as a key instrument and entry point towards more effective development cooperation, in that these cover the full range of financing resources, support the bridging of short to longer term planning, and provide measures for added transparency and collective accountability.

### 2.2 South-South Cooperation and Triangular cooperation

- Argues how these complementary partnering modalities foster greater country-level ownership of development co-operation.

### 2.3 Effective private sector engagement through the Kampala Principles

- Demonstrates how improving partnerships through the Kampala Principles can unlock the transformative power of effective private sector engagement to deliver the SDGs and leaving no one behind. The Kampala Principles serve as key enablers for building trust, reconciling business and development priorities and engaging the private sector where it matters.

### 2.4 Providing an enabling environment for civil society as independent development actors in their own right

- Discusses the importance of engaging civil society and other development actors at all levels – global, regional, national and local– in multi-stakeholder settings to deliver more results for people and planet.

## 3. REFORMED MONITORING AS THE KEY PILLAR FOR ANCHORING EDC AT THE COUNTRY LEVEL

- Argues how the GEPDC monitoring exercise underpins more effective development co-operation through a virtuous circle of inclusive dialogue, collective accountability, tracking results and agreeing on actions towards stronger development outcomes.
- Highlight the monitoring relaunch in 2023 and the novel elements on process and framework, as well as monitoring reforms to do with LNOB, SSC and fragility.
