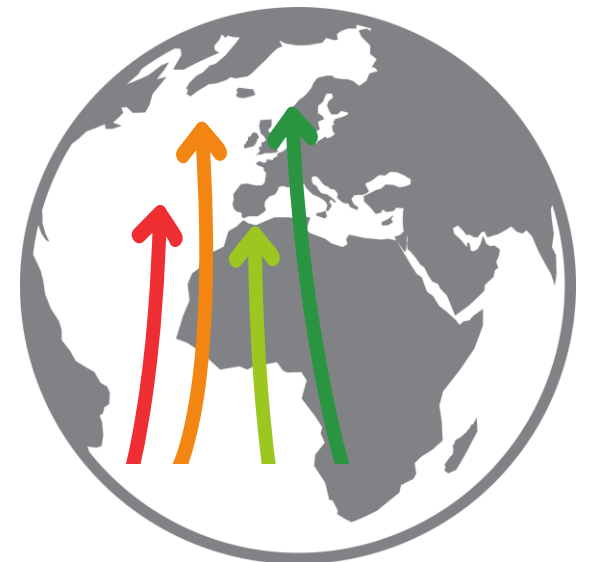
- Start with fragility
